Dear Owner,

First of all, I want to wish each of you, as well as your families, to be in good health. These are moments when it is up to each of us to get the best of ourselves, to show strength, integrity, solidarity and compassion. I want to express my feelings, and words of comfort for those who may have lost a loved one.

As you know, the Government of Spain decreed that in order to enter the Canary Islands and the rest of Spain, the PCR test would be required. Later, the Canarian Government issued a Decree that established that in addition to the PCR test, approved RAPID DETENTION TEST OF ANTIGENS will also be accepted as a diagnostic test for COVID-19. The change was an important advantage, since antigen tests are easier to obtain, more affordable and the waiting time to obtain the results is minimal, thus guaranteeing that the corresponding certificate will be ready when you fly. However, the Canarian Government Decree has been appealed by the Government of SPAIN, so that currently TO ENTER THE SPANISH TERRITORY THE ONLY VALID DOCUMENT IS THE PCR TEST.

The test must be in writing, with identification of the Center that issues it, the person who has taken it, date and time, it must be 72 hours before the trip and to all people over the age of 6.

My apologies for the continuous changes in criteria and regulations, but they are decisions of the Government of the Canary Islands and Spain.

Yesterday the Canarian Government announced a series of new restrictions for the island of Tenerife, including the restriction on entry and exit from Tenerife. This restriction does not affect tourists who plan to come to the island on vacation will be staying in touristic establishments as long as they present a negative

Every day we continue working from WIMPEN, together with its President and Committee, to ensure the future of your Resort, with the confidence that together we will come out strong and reinforced, in this complex situation.

I hope that the vaccine can be applied soon and the travel bans, quarantine and legal limitations, may be things of the past, although we do not have absolute normality, we can enter a phase in which we can all visit our beloved Resorts and share among all of us as we have done all the previous years.
